MEPZ AUTHORITY CIRCULAR

Implementation of Single vendor for Comprehensive Waste Management System in MEPZ

Dear Unit Heads/Director,

As part of MSEZA's on-going commitment to sustainability and effective waste management, we wish to inform a significant update regarding the comprehensive waste management plan within MEPZ SEZ.

Currently, MSEZA contracts a vendor who is responsible for collecting general garbage and office waste throughout the Zone. This vendor collects office and food waste and transports it to their yard for further processing. However, the management of production waste generated by individual factories and Units are not part of this vendor's responsibilities.

MSEZA has decided to provide a comprehensive waste management solution aimed at achieving zero waste disposal within the zone. The proposal is designed to minimize the environmental impact, conserve valuable resources and set a sustainable waste management practice.

To streamline and enhance our waste management processes, it is proposed that all Units within MEPZ SEZ shall dispose of their duty payable and non-duty payable waste through a single vendor contracted by MSEZA. This initiative is aim to support recycling and reuse initiatives, ensuring that all generated waste within MEPZ are managed responsibly. The proposal was presented during the 30th authority meeting held on 16.08.2024, wherein, after careful examination/consideration, the same was approved by the committee.

In the light of the above, we kindly request all Units to adhere to this new initiative for waste disposal process and collaborate with the designated vendor for the disposal of all types of waste. Detailed guidelines and contact information of the vendor shall be shared shortly.

We urge all Units to take this initiative responsibly and revert with your consent form (enclosed) on top priority. We solicit your cooperation for the successful implementation of this go green initiative and we look forward to working together to achieve zero-waste goal.
